### A quick recap on the Local Plan – known as Regulation 19

**16a** - Hammonds Farm consists of a sprawling estate of 3,000 houses and 500,000 square feet of industrial area/distribution warehouses.

**16b** - involves an additional 500,000 square feet of industrial area/distribution warehouses, including 88 HGV docking bays.

These **massive developments** will forever alter the character of our area. If this goes ahead, this beautiful area will become part of the urban sprawl of Chelmsford City.
